

## A Way Forward and the United Methodist Churchi

Within the United Methodist Church, there has been a decade's long debate on the church's official stance on the inclusion of LGTBQ persons within the denomination. On all sides of the discussion are Christians who love Jesus, who are passionate about making disciples of Jesus and who are connected in one church body. At the same time, they have significantly different convictions about how to interpret and apply scripture, reason, tradition, and experience to the inclusion of LGTBQ persons in the church. The debate has taken significant energy within the denomination. Some Pastors, Annual Conferences, and Jurisdictions within the denomination have made the decision to not follow the Discipline's prohibitions on marriage and ordination of pastors.

What happens when Christians in the same body disagree about an issue that elicits such strong reactions? What happens when the church is stuck in a cycle of debate and feels at a stalemate? What happens when the conflict between believers seems to become the main thing instead of the mission of making disciples? How do we find a way through the conflict while doing the least harm and prioritizing our mission of making disciples of Jesus?

This is why the General Conference voted in 2016 to try a new process covered in prayer and to trust the guidance of the Holy Spirit. The goal is to find a way forward that changes the dynamic in the denomination and allows us to focus on our mission of making more disciples of Jesus Christ. And at the same time, find a way that does this with the least harm to the mission of individual congregations and is most effective at promoting unity in Christ. A Special Commission titled "A Way Forward" was established by the Council of Bishops and the General Conference to do this work and bring back a report.

The Commission was "to do a complete examination and possible revision of every paragraph of the Book of Discipline concerning human sexuality and explore options that help to maintain and strengthen the <u>unity</u> of the church." The proposal was approved, and a 32-member commission was named in October of 2016. The commission was chosen to specifically represent the full spectrum of beliefs concerning human sexuality within the denomination."

That report was presented in May of this year and contained a selection of three different paths our Denomination might choose. A summary sheet of those choices is attached in chart comparison formats.<sup>iii</sup> This will be the issue discussed in a Special Session of General Conference in February of 2019. The Council of Bishops has endorsed the "One Church" plan. The final decision will be in the hands of the Conference in February.<sup>iv</sup>




## **Preparing for the Conversations and Decisions**


TODLS FOR TALKING WHEN STAKES ARE HIGH
